BAS Meeting Minutes, 7/8/2020

On-line Zoom Meeting

The meeting was called to order at 6:30 pm by President Aidan Sesnic.

The minutes from the July meeting were approved.

Bill Mansfield reported that there was no significant news pertaining to his role as AMA Safety Officer.

Chester Sans reported on the that we have 76 members and 23 float flyers, compared with 70 members as of last July.

Treasurer Dean Ehn reported on the club's finances.

Other club officers were not present for the meeting.

President Aidan Sesnic noted that the field restrictions changed about 10 days prior to the meeting so as to open up the southwestern quadrant of the field. All other aspects of the field restrictions remain unchanged.

Previously there was a request to look into the possibility of retrieving airplanes which might go

Aidan reported on a few changes to the city manager rules:

- Language stating that dogs must be on a leash and held by the owner. City rules expressly prohibit the dog from being restrained by tying the leash to a post, trailer hitch, etc.
- Language will be changed to permit people to occupy the runway to place their aircraft on the runway for takeoff.

Al and Rich expressed interest in discussing weed spraying but were not present at the meeting. This matter is tabled and will be revisited in August.

Aidan reported that he's received word of scams where the scammer pretends to be him and requests money, gift cards, etc. A BAS officer will never request gift cards over email. Other members at the meeting reported that this issue has been ongoing for several years. The meeting was adjourned at 6:53 pm.

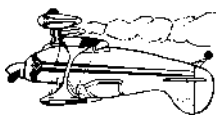
